

**Pets' policy - Staying with Little Friends.**



*A warm welcome to THALASSA BOUTIQUE HOTEL & SPA!*

*We are very pleased to welcome your dog as our guest!*

*This document serves to inform you of the guidelines to have in mind during your stay with us always in consideration of our other guests, the hotel surroundings and in line with the common rules of hygiene. We welcome all domesticated dogs that are trained, well behaved, calm, non-aggressive, travel-savvy and accompanied by their owner. We don't discriminate on breed but we reserve the right to not accept dogs and request their departure from the facilities if they present themselves with aggressive behaviour, are unable to remain quiet, or if our Terms & Conditions are not respected.*

- *The definition of pets applies only to dogs. No other animal may be kept in the property.*
- *The hotel allows only domesticated dogs that weigh less than 22 lbs. (10 kg) to stay in our accommodation.*
- *No more than one pet per room is permitted*
- *The cost of stay is € 15,00 per night. The fee covers the in-room amenities package which includes the dog bed, waste bags and a placement set with food and water bowls. These items should be left in the room for the next guest.*
- *The guest must be adequately equipped for the welfare of their pet, including carriers and travel kennel.*
- *Dogs must be declared prior to check in/registration.*
- *Dogs should not be in heat or menstrual period during time of check in and not have been sick in the last 72 hours.*
- *It is not allowed to let the animal on the beds, armchairs, chairs, tables etc.*
- *The pet must be accustomed to living in a house and with a cleaning regime. Excessive barking may disturb other guests or room neighbours. If your pet is causing too much disorder or noise pollution, you may be asked to vacate the property without reimbursement.*
- *Dogs are unfortunately not allowed in the indoor Ambrosia restaurant in respect to other guests.*
- *Dogs are welcome in the hotel lobby area, pool and beach bar sunbed area and outdoor Ambrosia and Psari restaurants as well as the outdoor Ippokampos beach bar area, when accompanied by their owner and on their leash.*
- *It is not allowed to use the bath/showers or the towels or sheets in the room for cleaning/drying your dog.*
- *New places can feel strange, therefore it is not allowed to leave your dog alone in the room longer than 2 hours.*
- *Kindly use the "Do not disturb" sign when leaving your dog alone in the room. This way we avoid unpleasant surprises for your dog and our staff. For reasons of safety and comfort of your pet, the house cleaner will not clean the room if your pet is left unattended. If you are present during the time the house cleaner is in your room, your pet must be restrained. Please contact the Housekeeper about the appropriate time to clean the room.*
- *Dogs are not permitted in the Wellness areas. Spa, gym and indoor swimming pool.*
- *In accordance to Cyprus legislation, all pets must be enclosed in pet carriers or restrained on a leash in all public areas and walkways. Moreover, all litter caused by the dog is required to be removed by guest.*

- *It is important to confirm that your pet has all required and up to date vaccinations and inoculations and does not have to the best of your knowledge, any communicable illnesses or diseases.*
- *Any damage to hotel goods or property caused by the pet will be compensated by each guest in full. Damages which may include, but are not limited to, stained bedding, stained carpet, stained linen, scratches on the furniture, scratches on the floor, infestation, extra cleaning that may be required and lost revenue charges whilst the room is out of service due to cleaning and repairs. Guest's room is subject to damage inspection at any time and upon check out.*
- *Management reserves the right to make any changes to this policy at any time.*

*I hereby accept Thalassa Boutique Hotel & Spa Regulations and agree to pay for any charges deemed necessary, for cleaning or repair due to pet stains and/or damage, as determined within, by the sole discretion of the hotel.
